To amend the Intermodal Surface Transportation Efficiency Act of 1991 with respect to future interstate designations, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Ports-to-Plains High-
- 5 way Act of 2021".

1	SEC. 2. FUTURE INTERSTATE DESIGNATION AND OPER-
2	ATION.
3	(a) Inclusion of Certain Route Segments on
4	Interstate System.—Section 1105(e)(5) of the Inter-
5	modal Surface Transportation Efficiency Act of 1991 is
6	amended—
7	(1) in subparagraph (A)—
8	(A) by inserting "subsection (c)(14)(A)(ii)
9	(relating solely to the portion from Limon to I–
10	76 in the vicinity of Brush)," after "subsection
11	(e)(13),"; and
12	(B) by inserting "subsection (c)(38),"
13	after "subsection (e)(37),"; and
14	(2) in subparagraph (C)(i), by adding at the
15	end the following: "A State having jurisdiction over
16	any segment of the routes referred to in subsection
17	(c)(14)(A)(ii) (relating solely to the portion from
18	Limon to I-76 in the vicinity of Brush) or (c)(38)
19	shall erect signs, as appropriate and approved by the
20	Secretary, identifying such segment as a future ad-
21	dition to the Interstate System.".
22	(b) Vehicle Weight Limitations.—Section 127 of
23	title 23, United States Code, is amended by adding at the
24	end the following:
25	"(v) Operation of Vehicles on Certain Texas,
26	OKLAHOMA, COLORADO, AND NEW MEXICO HIGHWAYS.—

- 1 If any segment of the routes referred to in section
- 2 1105(c)(14)(A)(ii) (relating solely to the portion from
- 3 Limon to I-76 in the vicinity of Brush) or section
- 4 1105(c)(38) of the Intermodal Surface Transportation Ef-
- 5 ficiency Act of 1991 is designated as a route on the Inter-
- 6 state System, a vehicle that could operate legally on that
- 7 segment before the date of such designation may continue
- 8 to operate on that segment, without regard to any require-
- 9 ment under this section.".
